GUIDE
OF THE FORUM

Context

Considered as the skill to lead and coordinate collective action to achieve common goals, governance, considered as an institutional and organizational process, attracted for a number of years, the attention of many governments and institutions.

The core issue is to determine (or identify) the ways and means that allow strengthening this skill, which itself requires strengthening and developing the capacities of Men and more specifically those of senior officials.

In 2015, the China National Academy of Governance (CNAG, formerly known as the China Academy of Governance) signed a memorandum of understanding on a partnership with the Algerian Ministry of Interior, Local Authorities and Territorial Planning (MILATP). Both parties have established a stable partnership in the field of the capacity building of high-level human resources.

Since the launch of this partnership, more than 400 senior Algerian officials participated in training seminars organized between China and Algeria.

The successful holding of those activities has provided strong support for the construction of high-quality human resources of Algerian central and local governments, and ensure a high-end exchange platform for the mutual learning on governance capacity building of the two countries.

In this context, the international forum which will be held on 4 and 5 December 2018 in Algiers will be an opportunity to compare several visions around the topic of capacity building in governance with a view to strengthening Sino-Algerian cooperation, and expand it to other international partners.

Objectives

The forum aims, consequently, to jointly develop recommendations, build a global partnership network, and identify and explore the next steps

of bilateral and multilateral cooperation on knowledge sharing and global governance capacity-building.

At the conclusion of this Forum, MILATP will develop a national strategy of collaboration that will address fundamental issues for an integrated development and a homogenous recast of the national training system in the field of governance.

This Forum will be organized around the following three (03) themes:

- Global trends on governance capacity building;
- How do governance schools (public affairs, public policies, administration, etc.) help to improve the effectiveness of the public service through their double role in scientific research and consultation for decision-making?
- How to benefit from the activities of partnership and international cooperation in the field of governance capacity building?

Expected results

The expected results of this Forum are:

- Identification of specific elements and recommendations for the establishment of a new training program on governance, based on global trends in governance capacity building;
- Development of a coordinated strategy on how schools of governance (public affairs, public policies, administration, etc) will be involved in the field of scientific research and decision-making consultation, and in this effort, will establish links with other national and international partners.
